

AFFIDAVIT OF FIREARMS & ESTATE SECURITY DIRECTIVE

1. Declaration of Private Right

I, **Karra-Leanne: Corbet**, of the House of Corbet, a **private woman** and **Beneficiary of the private estate trust** registered under **Birth Certificate No. 1970/7247**, affirm that I retain the **irrevocable right** to acquire, possess, and operate **firearms and equivalent defensive tools** for the protection of:

- My own private capacity and equitable estate;
- Any estate property, land, vehicle, or commercial interest held in trust;
- Lawful residents, family members, and declared heirs of the private estate;
- Any estate or commercial interests operated under **Mataya Securities Trust** or **Phoenix Securities Trust**.

This right arises under **natural law, trust obligation, and fiduciary necessity**, not from legislative grant.

2. Jurisdictional Rebuttal

I do not appear as a **citizen, subject, licensee, or participant** under any **public regulatory scheme**, including but not limited to:

- **Weapons Act 1990 (Qld)**;
- **Firearms Act 1996 (SA, VIC, NSW, TAS, ACT)**;
- **Crimes Act 1914 (Cth)**;
- **Arms Regulation 2003 (NT)**;
- **Firearms Act 1996 (Cth)**;
- Any **corresponding licensing, seizure, or disarmament legislation**.

3. Fiduciary & Diplomatic Exception

Upon the issuance or judicial recognition of:

- Recognition of a **DFAT-issued diplomatic credential, international protocol card, or Private Diplomatic ID;**
- Recognition of a private health policy in trust (e.g., **Medibank Private or equivalent high-tier coverage;**
- **Judicial sealing of this Affidavit by the Supreme Court of Queensland;**
- Acceptance of **PPSR liens, Security Agreement, and trust status.**

Then this directive becomes **fully operational** and entitles the Beneficiary to:

- **Acquire, import, transport, store, and operate firearms for estate defence;**
- **Refuse registration or seizure by any public authority;**
- **Carry or store defensive tools** within estate property, vehicle, or on the **Beneficiary's** person if reasonably required;
- **Prevent any officer, agent, or registrar from initiating prosecution or seizure** without express leave of this **Honourable Court sitting in personam** under equitable jurisdiction.

4. Emergency Scope and Estate-Wide Application

This directive shall apply equally to:

- **Grant-David: Johns**, private man and Principal of **Phoenix Securities Trust;**
- Any **declared heirs or family members** residing within the estate or travelling under trust protection;
- Any **estate vehicle, mobile structure, or trust-held property** used to secure estate personnel or materials.
