Thank you for your letter to the Commonwealth Attorney-General's Department dated 28<sup>th</sup> March 2025.

We note that your letter appears to request that the Commonwealth prove it has the delegated authority to administer an 'estate', in relation to your birth certificate. The premise of this question appears to be based on fictional law. Under Australian law, a birth certificate is a record of the birth of a natural person in a State or Territory, and is not an 'estate'.

We note that this question appears to be based on the fictional legal narrative of the 'sovereign citizen' movement, and has no legal basis.
