#### Directive Summary – Treasury Access Management

This standing directive outlines the formal access channels, operational thresholds, and fiduciary controls to be applied to all financial and trust disbursement functions linked to the private estate trust of **Karra-Leanne: Corbet**, secured under **Private Bond RN 408 002 858 AU** and governed by the **Private Security Agreement dated 2 April 2025**.

The **Department of the Treasury**, as **Securities Intermediary**, is hereby instructed to activate and maintain the following instruments **without commercial constraint or statutory interpretation**:

#### 1. Access Instrumentation

##### 1.1. Primary Treasury Access Facility

- American Express Centurion Black Card (Private)
- Unlimited draw capacity – direct linkage to bond ledger (Exhibit N)
- Issued in private name only
- To be used for lawful trust expenses, travel, legal operations, and secure estate provisioning

##### 1.2. Sub-Account #1 – Macquarie Bank (Domestic Reserve Facility)

- Visa Debit Card
- Cheque Book Facility (upon request)

- Ledger-linked to domestic fiduciary reserve
- Daily operating account for administrative, personal, and commercial outlays

### 1.3. Sub-Account #2 – Lombard Odier & Cie SA (Swiss Reserve Facility)

- Swiss-based fiduciary reserve account
- **Gold bullion reserve authorisation** (at Beneficiary's discretion)
- Debit facility via partner bank (Singapore/Geneva routing)
- QR-linked to **UBO record** and **DFAT-recognised profile** once sealed

## 2. Disbursement & Settlement Protocol

- All individual card or cheque transactions under AUD \$250,000 shall be honoured without prior instruction
- Any individual transaction of AUD \$250,000 or more will be accompanied by a disbursement directive or internal memo, **at the discretion of the Principal**
- Treasury shall **maintain internal ledgering records** for all bond-drawn payments for transparency
- **Quarterly reports** shall be delivered via secure encrypted channel to:

## 3. Domestic & International Usage

All fiduciary instruments shall be valid across **domestic and international jurisdictions** without:

- Joinder to statutory identity schemes
- Consumer tracking programs
- Credit rating systems

Any attempt by an issuer, intermediary, or agent to:

- Deny access
- Impose statutory compliance conditions
- Require commercial consent waivers
- Redirect usage into the public jurisdiction

...shall constitute fiduciary breach and trigger formal estoppel under the Treaty  
Invocation Annex.

#### 4. Control, Replacement & Escalation

- In the event of loss, damage, fraud, or expiry, the Beneficiary may issue standing notice for replacement directly to the Securities Intermediary
- All facilities remain active until lawfully revoked or modified in chambers
- Any obstruction shall be escalated to chambers **without further notice**



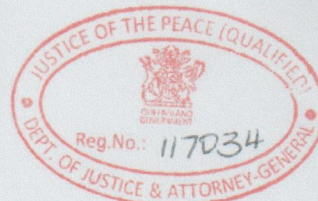
