I, **Karra-Leanne: Corbet**, the living private woman, appearing in chambers as **Grantor, Principal, and Beneficial Owner** of the trust estate associated with **Registration Certificate No. 1970/7247**, do hereby issue this fiduciary instruction under original equitable jurisdiction in personam.

This directive is issued pursuant to the **Private Bond for Set Off (RN 408 002 858 AU)**, perfected under PPSR lien, and supported by the lawfully served **Notice of Equitable Directive dated 17 June 2025** and the **Private Security Agreement dated 2 April 2025**.

You are hereby instructed, in your capacity as Securities Intermediary, to activate the following fiduciary access facilities without delay:

1. Primary Access Facility – AMEX Centurion

- Issue **American Express Centurion Black Card**
- Directly linked to **Bond Ledger RN 408 002 858 AU**
- **Unlimited transactional authority**
- Delivered in trust, without statutory restriction or consumer limitation

2. Sub-Account #1 – Macquarie Bank (Domestic Reserve)

- Establish **private trust-linked account** in the Beneficiary's name
- Enable **Visa Debit Card** and optional **Cheque Book facility**
- Integrate with the trust's daily administrative functions, domestic mobility, and lawful affairs

3. Sub-Account #2 – Lombard Odier & Cie SA (Swiss Reserve)

- Open **international fiduciary account** under private estate trust
- Debit card issuance via Lombard's clearing partner (e.g., **Singapore or Geneva branch**)
- Enable **gold-backed reserve option**
- Link to **UBO profile**, Mataya Securities Trust, and **diplomatic credential** upon DFAT issuance

Any failure, delay, or substitution of nominee channels shall constitute:


- Constructive dishonour
