1. Declaration of Estate Insignia

- 1.1. I am the lawful owner of the **personalised number plate “G JOHNS”**, issued by **Personalised Plates Queensland (PPQ)** and presently held in unassigned reserve under my name.
- 1.2. This plate has **never been registered to any vehicle** and has always been held as private **estate insignia**, not as a commercial or consumer asset.
- 1.3. The plate is now formally declared to be an **equitable identifier and symbolic estate marker**, signifying my standing as Beneficiary of the estate trust.

2. Secured Status under PPSR

- 2.1. The plate is secured under **PPSR Registration No. 202508150000944**, registered on **15 August 2025**, and classified as **Commercial Property**.
- 2.2. The secured party is **Phoenix Securities Trust**, acting as **Lienholder** under the **Private Security Agreement** dated **2 April 2025** [Exhibit B].

2.3. The PPSR description reads:

Held pursuant to the Private Security Agreement dated 2 April 2025. Secured by Phoenix Securities Trust under lien for equity enforcement and estate preservation."

3. Fiduciary Instruction to DTMR and Public Officers

3.1. Upon assignment to a trust-held vehicle, I shall issue **formal written notice** to the **Department of Transport and Main Roads Queensland (DTMR)**, enclosing this affidavit and confirming jurisdiction in equity.

3.2. **DTMR shall issue written confirmation of the assignment within ten (10) business days** of receiving notice, addressed to:




...shall constitute **trespass upon the trust, breach of fiduciary obligation, and grounds for immediate injunction or equitable remedy.**

3.4. This plate is held and used solely under **jurisdiction in personam**, and shall be subject to no conditions, levies, or controls without **lawful leave of this Honourable Court.**

This affidavit is to be:


- Lodged and sealed as **Exhibit W** in the Supreme Court filing bundle;




