RE: Final Clarification of Equitable Claim – EC25-001964

Dear Director,

Thank you for your correspondence dated 30 June 2025, received on 8 July 2025. This letter serves as my final clarification and good faith reply concerning the matter raised under formal **Notice of Equitable Claim and Fiduciary Directive**, which was executed and sealed on **23 June 2025** and duly delivered to your office via Australia Post on **27 June 2025**, constituting lawful service.

The matter concerns all interests associated with **Services Australia / Centrelink reference #404 278 838 C**, which have been expressly withdrawn from general deposit and re-deposited under a **private and permanent Special Trust**, as established under Clause 7(d) of the directive. These interests now fall exclusively under equitable jurisdiction and are to be administered accordingly.

You are respectfully reminded that:

- This matter is **not a complaint** nor a request for a discretionary benefit;
- It is a **fiduciary notice** requiring the reclassification of all associated records and identifiers in recognition of the Beneficiary's equitable standing;
- All **rights, titles, and interests** now vest in equity, free of joinder to any statutory scheme.

You are hereby directed to facilitate a **fair and proportionate exchange of interest from the private estate (RES)** sufficient to maintain uninterrupted benefit under the **Medibank Private Gold Ultra Health Policy**, including the Emergency Department Benefit. This shall not be construed as an application for public welfare, but as a lawful settlement in equity for services rendered, and must be administered **without prejudice to the Beneficiary's standing**.

For clarity, **any expired or current Medicare card**, whether active or inactive and bearing a public Customer Reference Number (CRN), is not to be construed as evidence of joinder, waiver, or consent to a statutory scheme. These identifiers are hereby reclassified as **constructive trust property** under the Special Trust.

Should your agency fail to perform or continue to mischaracterise this matter, a **formal application for relief in equity** will proceed in the **Supreme Court of Queensland – Trial Division (In Equity)** without further notice. This may include declaration of breach, demand for accounting, and such equitable orders as may be just and necessary.

You are hereby granted **fourteen (14) days from the date of receipt** of this clarification to acknowledge and fulfil your obligations under the trust. Failure to respond or perform shall be taken as wilful breach and default in equity.

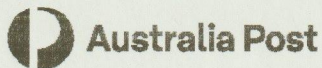
