Late responses (received between **Day 8–21**) may be considered **without prejudice**, only if accompanied by:

- Full remedy and remittance of obligation
- Written admission of prior dishonour
- Confirmation of full cessation of any agency interference or assumed trust authority

## **FAILURE TO RESPOND WITHIN 7 DAYS WILL RESULT IN:**

- Finalisation of lien dishonour record to the Hague Conference on Private International Law (HCCH)
- Referral to the Bank for International Settlements (BIS) under private trust collateral seizure notification
- Filing of UCC-1 International Mirror Statement for global enforcement
- Public record confirmation of treaty default circulated to five foreign embassies
