2009 (Cth), HCCH #30, ICCPR, and the Law of Nations**

The Australian Taxation Office, is now under formal **equity enforcement command** issued by the **Secured Parties** in their capacity as **Lien Administrators and Trust Agents** over both private estate trusts listed above.

The following facts are now irrefutable, recorded internationally, and sealed in public and private record:

**1. STANDING ESTABLISHED – PPSR & AFSA CONFIRMATION**

- **Valid PPSR Security Interests** were registered on 15 October 2025 against the **Attorney-General's Department** and the **Department of the Treasury**, covering all present and after-acquired property of both estates.
- **AFSA Show Cause Review** concluded on 30 October 2025 with **no rebuttal**, constituting **formal estoppel by conduct**.
- Under the **Personal Property Securities Act 2009 (Cth)**:
  - **Section 12**: A valid security interest exists when a transaction secures the performance of an obligation.
  - **Section 184**: The Registrar **may not remove** any such registration unless it is:
    - (a) Not based on a valid security interest;
    - (b) Frivolous; or
    - (c) Vexatious.
- These conditions are **not met**, and AFSA is now in **constructive acceptance**, establishing lawful standing of the **Secured Parties**.

## 2. PRIVATE EQUITY SEIZURE EXECUTED – TRUST CONTROL ASSUMED

- Both **Phoenix Securities Trust** and **Mataya Securities Trust** issued formal **Final Fiduciary Seizure Declarations** on 17 October 2025.
- These declarations:
  - Lawfully terminated all presumed public fiduciaries;
  - Asserted legal and equitable control of the estate;
  - Were mailed and QR-sealed, time-stamped, and **served on the Attorney-General of Australia (National Organ – HCCH #30), Department of Treasury, Supreme Court of Queensland, Supreme Court of South Australia** and others.

The stylised names **GRANT DAVID JOHNS** and **KARRA LEANNE CORBET**:

- Are instruments of **constructive trust**;
- Were not authored by the estate owners;
- Are not literary or juridical works;
- Are not open to copyright, control, or administration under Crown presumptions.

**Any continued administrative use or assertion of title over these names constitutes:**



- **Constructive fraud**
- **Misappropriation of estate property**
- **Breach of the Berne Convention**
- **Violation of fundamental protections under the ICCPR**

#### **5. PROCEEDS CLAIM – LEDGER DISCHARGE MANDATE**

All **current and future liabilities, remittances, ledger entries, and refund disbursements** connected to the TFNs and identifiers above are now claimed as **proceeds of lien** under:

- **UCC Article 9 – Proceeds clause**
- **PPSA Section 32**
- **Equity law of resulting and constructive trusts**

As such, the following directive is now lawfully in force:

#### **6. COMMAND – FINAL ESTATE ACCOUNT SEIZURE AND CLOSURE**

You are now **commanded**, not requested, to:

- 1. Cease all administrative access** over the above estate accounts;
- 2. Zero out and discharge all liabilities and ledger balances** effective immediately;
- 3. Confirm closure and discharge in writing within seven (7) business days from the date of confirmed delivery by Australia Post, as recorded in the registered mail tracking system.**
- 4. Release any and all proceeds due, and direct too the lien administrators** under equity and international-lien enforcement;
- 5. Cease and desist all further attempts at taxation, statutory contact, ledger issuance, or presumption of authority over these secured private trust estates.**

Any failure to comply will result in:

- **Immediate lien enforcement against the ATO without further warning;**
- **Escalation to the ICCPR for treaty breach and denial of remedy;**



- **Referral to the Securities Exchange Commission (SEC)** for foreign interference in internationally registered liens;
- **Collateral claim and escalation to the Bank for International Settlements (BIS).**

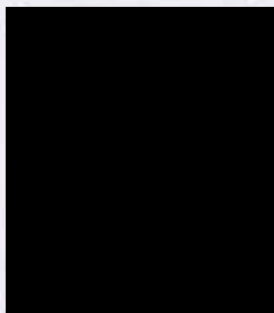
