
Relief sought: *Declarations, fiduciary orders, equitable remittance, and enforcement in chambers*

Dear Registrar,

I respectfully lodge the enclosed materials for filing in **equity** as a **Special Matter**, to be placed before a Justice sitting in **chambers** at the earliest opportunity.

The Applicant requests that this **Special Matter** be heard and determined entirely in camera, without adjournment or transfer into public, statutory, or commercial jurisdiction, and that **all instruments remain preserved under seal in the private equity record**.

This matter arises under the **original equitable jurisdiction** of this Honourable Court and proceeds in **personam, nunc pro tunc ab initio**. It seeks **declarations, fiduciary directions**,



and **remedial enforcement** concerning a private trust estate established in the State of South Australia. The trust estate originated with the registration of the Applicant's live birth in South Australia, making this Court the **proper and competent forum**.

All matters at issue relate to:

- **Fiduciary failure and constructive dishonour by the Original Trustee and all subordinates acting under, through, or in association therewith;**
- **Constructive use of the trust res;**
- **Unrebutted fiduciary notice; and**
- **Estoppel arising from failure to perform under trust.**

This is **not** an application for review, appeal, or statutory relief under the **Bankruptcy Act 1966 (Cth)** or any other Commonwealth legislation. Any reference to "bankruptcy" herein is expressly to a **purported bankruptcy only**.

The Applicant appears in **equity only**, to:

- **Assert lawful standing;**
- **Seek remittance; and**
- **Correct unauthorised use and administration of securities, certificates, and estate instruments perfected by private lien.**
