- **1.3.** These plates are **not commercial assets** or consumer products, and their continued reservation is under trust authority only.

- 2.2. The secured party is Mataya Securities Trust, acting as Lienholder under the Private Security Agreement dated 2 April 2025 [Exhibit B].
- 2.3. The PPSR descriptions are as follows:

"Personalised number plate 'KARRA C', presently held as unassigned estate insignia and symbolic identifier under the equitable estate of Karra-Leanne: Corbet, recorded under Birth Certificate No. 1970/7247. Held pursuant to the Private Security Agreement dated 2 April 2025. Secured by Mataya Securities Trust under lien for equity enforcement and estate preservation."

"Personalised number plate 'CORBET', previously registered under the Beneficiary's name, now held in reserve as private trust insignia under equitable estate jurisdiction. PPSR-registered pursuant to the Private Security Agreement dated 2 April 2025, and secured by Mataya Securities Trust under lien for equity enforcement and record preservation."

- 3. Fiduciary Instruction to DTMR and Public Officers
  - 3.1. Upon assignment to one or more trust-held vehicles, I shall issue formal written notice to the Department of Transport and Main Roads Queensland (DTMR), enclosing this affidavit and confirming jurisdiction in equity.
  - 3.2. DTMR shall issue written confirmation of assignment within ten (10) business days of receiving such notice, addressed to:

## 3.3. Any attempt by DTMR or any other authority to:

- Assign either plate without express instruction in equity;
- Convert the plates into a public asset or revenue instrument;
- Register them under any legal fiction, statutory name, or presumed custodianship;
- Or link them to any public enforcement or digital registry...

...shall constitute trespass upon the trust, fiduciary breach, and shall trigger immediate remedy in equity, including injunction and estoppel.

**3.4.** These plates are **instruments of trust**, not public property. No statutory regulation, fee, enforcement protocol, or commercial scheme shall apply absent leave of this Honourable Court.

# 4. Digital Linkage and Record Preservation

## 4.1. This affidavit is to be:

- Lodged and sealed as Exhibit U in the Supreme Court filing bundle;
- Indexed in the private equity enforcement record;
- Referenced within the Mataya Securities Trust PPSR lien index;
- · Digitally linked to any lawful credentials or immunities recognised under equity or issued via the Department of Foreign Affairs and Trade (DFAT), including any diplomatic identifier or sealed equity recognition card.
- 4.2. Any interference, delay, or refusal to recognise these plates under trust shall be treated as constructive dishonour, breach of fiduciary duty, and administrative estoppel.
