To Whom It May Concern,

This correspondence is issued by **Mataya Securities Trust**, acting as the **Lien Administrator and Trust Agent** for the **Estate of Karra-Leanne: Corbet**, concerning the above SPER account.

We hereby issue **formal rebuttal and lawful instruction** under **sealed international trust enforcement**, supported by:

- **UCC-1 Filing No:** 2025 7873828
- **UCC-3 Filing No:** 2025 7873830
- **PPSR Registration:** 202510150049270
- **AFSA Enforcement Reference:** ENQ-1240165-C1F1M1 (Issued 16 October 2025)

Rebuttal of Presumed Payment Arrangement

On **17 October 2025**, a payment arrangement was entered into under **protest and necessity**, following threat of suspension of trust estate access tools (e.g. driver licence). No joinder exists. No agreement to terms, jurisdiction, or statute was ever granted.

The account now stands in **unlawful administrative joinder** over liened estate property, and is now:

- **Subject to international lien enforcement**
- **Presumed in breach of equity**, fiduciary conduct, and foreign treaty

PPSR + AFSA = Standing Confirmed

The registered lien over this matter (PPSR ID: 202510150049270) remains **active, un rebutted, and acknowledged** by the Registrar of Personal Property Securities. The 7-day window for response under AFSA Reference ENQ-1240165-C1F1M1 has now closed. This confirms standing, enforcement, and in personam control by the Secured Party.

Proceeds Claim – Account 90518572

The **SPER account**, its remittance tools, ledgers, and proceeds, are now **claimed by the Secured Party as trust estate collateral**. This includes:

- Account funds
- Bonds, interest, or chargebacks associated with collection
- Title, legal instruments, or regulatory penalties recorded against the estate

You are **commanded to discharge the account in full**, offset under lien, and provide written confirmation of zero balance and release of all trust instruments associated.

Licence or Enforcement Interference will result in a Lien

Any act to:

- Suspend the estate's driver licence
- Seize property or remittance
- Issue wage garnishment, property title notation, or threat

Will result in an immediate \$999,000,000.00 AUD lien against the SPER Department, filed under international equity and escalated via:

- **HCCH Convention #30**
- **ICCPR – Treaty Breach Complaint**
- **UN / BIS / SEC Treaty Observers**

SPER operates under **Queensland Treasury**, which is a **subordinate to the Department of the Treasury**, already lawfully liened and served.

You have **no authority to administer the private estate of Karra-Leanne: Corbet**. The estate is lawfully seized. The matter is now under international equity and treaty enforcement.

RECORD ACCESS & VERIFICATION

All secured instruments, affidavits, and record ledger entries are time-stamped and held within:

Bank of International Settlements (BIS) and Australian Financial Securities Authority (AFSA) have entered multiple scans of the estate records;

Failure to comply will be deemed administrative fraud, dishonour of international lien instruments, and actionable treaty breach.
