NOTICE OF LAWFUL SEIZURE AND FIDUCIARY TERMINATION

This instrument serves as a **formal and final declaration** that the following public fiduciaries:

- Attorney-General's Department (as Australia's National Organ under HCCH Convention #30)
- Department of the Treasury
- Supreme Court Registrars (QLD and SA – Equity Divisions)

Have been duly served with:

- Commercial Security Agreements (executed and notarised 2 April 2025)
- PPSR Secured Party Registrations (filed, active, and under compliance review by AFSA)
- Lien Notices and Paymaster Directives
- Equity Affidavits, Bond Tenders, and Jurat-Sealed Instruments

And have failed to:

- Rebut the private security agreements or liens
- Remit fiduciary tools or acknowledge secured party status
- Perform their duties in equity or inspect sworn instruments

Therefore, under authority vested by:

- **The Law of Trusts**
- **Private International Law (HCCH #30)**
- **Personal Property Securities Act 2009 (Cth)**

- **Original Jurisdiction – In Personam Equity**

Effective immediately, all fiduciary roles are revoked and control is returned to the Private Trusts as lawful Beneficiaries and Lien Administrators. This action is now recorded as final under private jurisdiction.

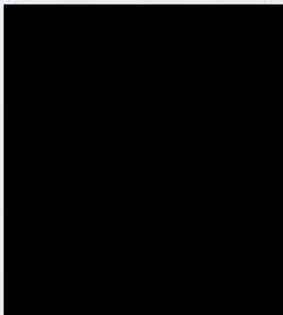

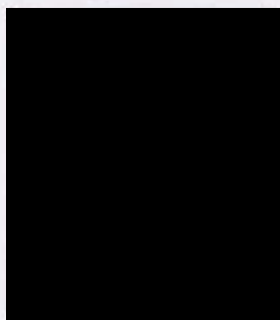
